Report from the President

Teamwork is Sacrificing Personal Glory for the Collective Victory

We are in the beginning of the GANA year and have already hit the ground running.

My first task as President of GANA was to address the NBCRNA proposed Continued Professional Certification Program (CPC). The Board of Directors met with a representative from the NBCRNA during the 2011 Annual Fall Meeting in Atlanta. We learned that we share many of the same concerns that other state associations are expressing. Surprisingly, however, there has not been a large number of Georgia CRNAs who have expressed their concerns to us regarding the CPC. Truthfully, most of us are apathetic, until our way of doing things is threatened. The leadership of GANA felt that certain aspects of the proposed CPC would negatively affect the way CRNAs practice in Georgia. Therefore, we sent a letter to the NBCRNA expressing concerns on behalf of Georgia CRNAs. A copy of that correspondence is included in this issue of *To and Fro* on page 3.

In October several GANA representatives attended the Composite Medical Board Meeting in Macon where draft guidelines for office based surgery were discussed. The meeting was attended by Christy Dunkelberger, GANA Executive Director and Legal Counsel; Barry Cranfill, Steve Smith and Rose Synsmir, GANA Past Presidents; and myself. Barry Cranfill also represented of the Georgia Board of Nursing at this meeting. GANA was well represented and was able to make comments and suggestions to ensure that CRNAs' practice was not affected by the guidelines.

Rose Synsmir and I attended the Georgia Association of Nursing Students (GANS) convention in October. We were accompanied at our booth with a great representation of CRNA schools, Mercer and the Georgia Health Sciences University. We had many nursing students question us about applying to CRNASchool and the advantages of being a CRNA. Both Mercer and GHSU programs are graduating great people who represent the CRNA community well.

The GANA has continued to provide the AANA with great leaders from Georgia who help to shape the nurse anesthesia profession. We are proud to continue that tradition. GANA has nominated Leslie Jeter for Region 2 Director, and Steve Smith for the AANA Nominating Committee for the AANA 2012 ballot. Both are

From the Executive Director

Happy New Year to all Georgia CRNAs! Pain Management

The area of pain management has been receiving a lot of press lately. Just recently, the local news has carried multiple stories of ‘pill mills’ being shut down by legal authorities. DEA and GBI narcotics personnel have initiated a full court press to shut down these so-called ‘pill mills’ that are issuing prescription pain medications illegally. Additionally the Georgia Legislature and the Georgia Composite Medical Board (GCMB) are taking steps to fight this battle. The GCMB has published proposed Rules that authorize the GCMB to take action against licensees for unprofessional conduct related to pain management. The Rules set minimum standards for prescribing controlled substances for treatment of pain and chronic pain. Interventional pain management is excluded from these proposed Rules. On the legislative side, one of the top priorities of certain legislators for the upcoming legislative session is to adopt legislation that establishes controls on prescribing and dispensing certain controlled substances. HB 184 has been pre-filed by Representative Weldon of the 3rd legislative district. HB 184 deals with monitoring the prescribing and dispensing of Schedule II, III, IV and V controlled substances. If you are involved in pain management services, I urge you to review the proposed unprofessional conduct/pain management Rules and HB 184.

2012 GANA Capitol Day

Plan to attend the 2012 GANA Capitol Day at the Georgia State Capitol on January 25, 2012. CRNAs need to get to know their legislators on a ‘recognition’ basis; and GANA Capitol Day provides you an opportunity to meet and mingle with your representatives and discuss the issues that are important to CRNAs. One of the GANA goals for 2012 is to be more recognizable in the public eye as well as to the legislators. Come out and join us for Capitol Day and make “CRNA” and GANA easily recognized by the Georgia legislators.

Guidelines Adopted for Office Based Anesthesia and Surgery by the GCMB

The GCMB recently adopted Guidelines for Office Based Anesthesia and Surgery. These Guidelines place restrictions on physicians who offer surgery and anesthesia services in the office setting. Restrictions apply to the anesthesia services when neither an anesthesiologist nor CRNA administers anesthesia. The adopted Rules are currently posted at the GCMB’s website.

RE: Proposed Continued Professional Certification Program

Dear President Krogh and Members of the Board:

On behalf of the Georgia Association of Nurse Anesthetists, and its 1039 CRNA members, I would like to provide you with several comments and concerns related to the proposed Continued Professional Certification Program ("CPC Program").

One of the concerns expressed by Georgia members is the requirement of thirty-five (35) continuing education credits per year. Some feel this amount is excessive and will cause undue hardship and expense for those CRNAs who do not live in close proximity to a metropolitan area. Those individuals, who for the most part reside in rural areas, will face the added burden of needing to plan for out-of-town overnight travel, on multiple occasions, to locations where continuing education courses are offered. They just simply do not have ready access to testing facilities and/or continuing education opportunities. They will also face the need to secure CRNA coverage during their times away and the loss of income from being away. CRNAs living in rural areas will have an added disadvantage over those who live in urban settings.

Another expressed concern originates with some CRNAs who have been in the workforce for multiple years. Their issue centers on the requirement to re-test for certification every eight (8) years. Older CRNAs feel at a disadvantage over their younger counterparts. They feel that this requirement of the CPC Program is an effort that will force them into early retirement.

Along the same lines as the above-stated concern and stemming from the same group of CRNAs is the concern regarding the failure to include a provision for grandfathering in the proposed CPC Program. Again the take away implication is that the older CRNAs are being penalized and being given no credit for their past experience.

Finally, the Georgia Board of Directors is concerned that some CRNAs may withdraw their membership from AANA as a result of the CPC Program. If there is a loss of members, the state budgets will be directly impacted. Georgia does not want to incur any financial losses.

Please give our comments your serious and careful consideration as you continue planning the CPC Program. We hope there will be revisions to the current proposal. Thank you for allowing us this opportunity to comment.

Non Deductibility of Dues for 2011

As required by section 6033(e) of the Internal Revenue Code, GANA is required to inform you that \$34.00 of your state membership dues are allocated toward expenses incurred by the GANA for state lobbying activities. GANA receives \$232.50 from the AANA for each full dues paying member. This amount is not deductible for federal income tax purposes. All GANA members are also members of the AANA. The AANA will include correspondence about the amount incurred for lobbying activities from the national dues in the AANA President's letter.

Around the AANA

I have just returned from the AANA Fall Leadership Academy in Newport Beach, California. It was good to see so many committed CRNAs together in such a picturesque setting! For those of you who could not join us, it was an uplifting and energizing meeting. We all worked together to tackle some of our profession's pressing issues, brainstorm ways of improving our state and national associations, and operationalize the "Fifty State Strategy." This initiative is focused on better meeting the needs of our members through the state associations. The ground swell of information came from the state leaders in attendance. The AANA leaders will now use this information to enhance our national association. It became clear that we all are striving to create a user-friendly organization that is not only responsive to our members, but aims to advance safe anesthesia care for our patients.

Just a few examples of the actions taken by your Board of Directors in response to your feedback:

- Your Program Committee is creating the plan to hold the 2013 AANA Annual Meeting in Las Vegas at the Mirage. Remember – what happens in Vegas stays in Vegas!
- The Program Committee has heard you loud and clear: August is a difficult month to plan "time off." The Board approved their recommendation to move the Annual meeting in 2014 to September. Neither the location nor the date has been confirmed yet. We realize, however, that many of you need to know so that your state meetings can be planned accordingly.
- Amid the storm of ideas generated by the Program Committee, the meeting schedule will be revised to make it easier for members to maximize their CE time while decreasing the meeting length by one day. Be on the lookout for some creative changes that will take our Annual Meeting far into the future!
- The new and improved AANA website will be going "live" on December 5, 2011. The search engine will be greatly improved and layout will be more user-friendly. The current site will

continue to work during this migration period, but no new information will be uploaded until the new site is active.

The Board of Directors also met for 4 hours with the NBCRNA board. The NBCRNA will be reviewing all comments received about the proposed CPC program through their website, the AANA website, and letters and phone calls made. An analysis will commence using a Delphi method. Three clinicians from the AANA Board of Directors will participate in the process. The NBCRNA Board of Directors is scheduled to meet again in mid-January to review the results of the analysis. They will present their findings to the AANA Board of Directors at the Board Meeting scheduled during the Assembly of School Faculty in February 2012. Both Boards have voiced a commitment to work together so that a solid process for validating continued competence is constructed and reflects member input.

The AANA BOD also met with the COA. The COA Board members are diligently working to increase efficiencies during this period of global economic uncertainties. They have assured us they are operating at full power and are becoming "lean and mean" (in a good way!). In the spirit of continuous improvement, the AANA Board also shared all feedback we have received from our members about our educational programs. The COA appreciated hearing our members input. A major revision of the COA Accreditation Standards for our Programs is in progress. The first call for written comments is planned to go out in March of 2012, following a hearing on the first draft of the Standards at the Assembly of School Faculty meeting in February of 2012. Our annual effort to achieve 100% membership renewal continues. AANA Foundation

The AANA Foundation’s new fundraising campaign-- Proof is Power, or P²--highlights the impact of scientific research and shines a bright light on the landmark 2010 studies “No Harm Found When Nurse Anesthetists Work Without Supervision by Physicians” (conducted by Research Triangle Institute and published in Health Affairs, August 2010) and “Cost-Effectiveness Analysis of Anesthesia Providers” (conducted by the Lewin Group, published in Journal of Nursing Economics, June 2010). These important studies were supported in part by the AANA Foundation, whose mission is to enhance the science of anesthesia through education and research. How Might the Congressional Deficit Supercommittee Affect CRNAs?

A powerful new congressional committee made up of equal numbers of Republicans and Democrats from the House and Senate could have great influence over CRNA reimbursement and practice as it begins work identifying at least \$1.2 trillion in federal budget savings over the next 10 years. The supercommittee has until Nov. 23, 2011, to present Congress with a budget reduction package, which Congress must then pass by Dec. 23 or trigger automatic federal spending reductions totaling about \$1.2 trillion, half from national security accounts. Because public benefit health programs like Medicare and Medicaid make up such a large segment of the federal budget and of anticipated federal spending growth, these programs are on the table for possible cuts that could impact CRNA reimbursement and practice.

AANA Urges CMS Action against Huge Medicare Payment Cuts

The Centers for Medicare & Medicaid Services (CMS) should take the lead in informing Congress about the huge impact that a 30 percent Medicare Part B cut to CRNA and physician payment would have on patient care in the United States, and should also fully recognize CRNA practice in every circumstance, said the AANA in a comment letter to CMS dated Aug. 30, 2011.

Medicare Agency Invites Providers to Apply for Bundled

Payments On Aug. 23, the Medicare agency issued a request urging healthcare facilities, groups and healthcare professionals including CRNAs to develop and submit to the agency requests for bundling payments for services to Medicare beneficiaries. A facility providing hip replacements, for example, could arrange to submit to CMS a single claim rather than four (facility, surgeon, anesthesia, physical therapy outpatient care). For CRNAs, the initiative provides opportunity to demonstrate to facilities and to Medicare the value of CRNA cost-efficiency in a way that can boost demand for CRNA services relative to those of more costly competitors.

Noteworthy

Infection Control in the News Surprise inspections of 21 Illinois surgery centers by the state’s department of public health revealed deficient infection control practices and resulted in citations for 14 of them. The Centers for Disease Control and Prevention (CDC) has a new “Stop Sticks” campaign that focuses on raising awareness and motivating healthcare workers to make the changes needed to reduce sharps injuries

Noridian Medicare Contractor Approves Acute Pain Reimbursement for CRNAs

On August 19, the Noridian Medicare contractor serving several Western states released an update to its March 17, 2011, bulletin titled “CRNA Practice and Chronic Pain Management” stating that it will allow reimbursement for acute pain management services provided by CRNAs, but not for chronic pain management services by CRNAs. AANA continues to take action with the Medicare agency to restore reimbursement for all Medicare services within the CRNA scope of practice – a move that assures our patients access to necessary care.

AANA Requests Voting Position on AMA-RUC

The AANA, in conjunction with other advanced practice nursing organizations and the American Nurses Association, has requested a voting seat on the American Medical Association’s Specialty Society Relative Value Scale Update Committee (AMA-RUC). The AMA-RUC is the recommending body to the Centers for Medicare & Medicaid Services on matters related to physician billing codes and their relative value. CRNAs bring extensive professional experience and insight into deliberations on anesthesia reimbursement and we look forward to contributing knowledge and expertise to the process.

Federal Government Affairs Update

From your Federal Political Director (FPD), greetings! I hope you all had a safe and wonderful holiday season and wish you all a happy, healthy and prosperous New Year. I would like to give special thanks to all of you that ended up renewing your GANA/AANA membership after receiving phone calls from your GANA Board members. Without your support and membership the GANA would have a much more difficult time protecting our scope of practice here in Georgia. \$232.50 of your AANA annual dues money comes back to the GANA to help finance the Georgia Association of Nurse Anesthetists. Thank you Board and thank you members!

I had the good fortune to attend the 2011 AANA Fall Leadership Academy, November 11-13 in Newport Beach, CA along with my colleagues from Georgia: Janice Izlar, Rose Synsmir, Leslie Jeter and Jim Masiongale. I attended a special 3 hour session specifically designed for Federal Political Directors to review in detail our responsibilities as an AANA FPD for the upcoming year. This is a very important time for us all due to the upcoming November 2012 Presidential election and Federal Congressional and Presidential primary elections and caucuses taking place all year long. Two critical CRNA issues facing us this year are huge Medicare cuts and maintaining access to CRNA interventional pain management which includes protecting Medicare direct reimbursement of CRNA chronic pain services.

The threat of a 26.2% cut to Medicare Part B CRNA payments has been temporarily averted. There has been a two months' relief from Medicare payment cuts packaged with HR 3630 extending a partial payroll tax holiday, certain unemployment insurance benefits, other temporary Medicare payment provisions and expediting the decision for construction of an oil pipeline. The relief expires February 29, 2012, meaning that unless Congress acts and develops legislation providing longer relief from Medicare cuts and a method for funding relief, the cuts will become a reality. Other CRNA legislative issues for Capitol Hill include protection of the provider nondiscrimination law for CRNAs, support of CRNA workforce development and to reject attempts to use federal policy to impair access to high quality healthcare by CRNAs. As you can see, we all have a lot of work ahead of us.

Of interest, CMS Administrator Donald Berwick MD, resigned December 2 and of this writing is to be replaced by Marilyn Tavenner, a registered nurse, highly regarded hospital administrator, and current principal deputy administrator of the Centers for Medicare and Medicaid Services (CMS). If she is confirmed by Congress this could bode well for both APRNs and CRNAs with respect to removing barriers to access to care.

Be one of 435 CRNAs serving as a Key Contact to Congress! I would like to encourage you all to consider joining the AANA Key

Contact program. I am in the process of updating and taking new volunteers to be a part of Georgia's Key Contact program. We currently have 13 Representatives and 2 Senators that we need Key Contacts for. As a Key Contact you will serve as a designated contact to your U.S. Representative member on behalf of the AANA to reinforce the legislative agenda of the profession of nurse anesthesia. Your job will be to localize and personalize the impact of issues affecting the profession of nurse anesthesia while building a strong ongoing relationship with your U.S. Representative. You must be willing to respond to CRNAdvocacy calls to action; provide updates to the FPD and the AANA D.C. office about contact with your legislator; assist with activities for CRNA-PAC; attend the AANA Mid-Year Assembly; and help mobilize other CRNAs into action.

There are many things you can do as a valued member of the GANA/AANA to help all CRNAs continue delivering accessible, high quality, safe and cost effective anesthesia care. First of all, become familiar with our issues. You can do this by visiting the AANA site www.caretobecounted.org (AANA member login required). Under the "CRNA Advocacy" tab you will find such information as CRNA legislative issues; taking action on the issues; studies from the IOM, Health Affairs and Nursing Economics; and becoming a Key Contact. Take time to read *Anesthesia E-ssentials*, which is delivered to you bi-weekly and contains a wealth of information including a section on Federal Government Affairs. Always respond to the AANA e-alerts when asked to write or send a letter to Washington.

The CRNA-PAC Annual Campaign will begin in January. Please consider answering the call to join the CRNA-PAC so we can assure CRNA issues and concerns are heard in Washington, D.C. Your CRNA-PAC is a non-partisan group that supports U.S. House and Senate candidates and campaigns with influence over or commitment to the issues that affect us all. Please visit www.caretobecounted.org to join up now!

Don't forget to sign up for the 2012 Mid-Year Assembly in Washington D.C., April 15-18. You can sign up online either at www.gana.org or www.aana.com. AANA's Mid-Year Assembly is your chance to travel to the Nation's Capitol and let your elected US Representatives and Senators know about concerns with legislative issues important to the nurse anesthesia profession. During this important event, we seek to build valuable relationships in Congress and promote awareness about the quality of care and cost effectiveness of nurse anesthesia services. GANA Past-Presidents. We will support these two Georgia CRNAs as they seek their respective AANA positions.

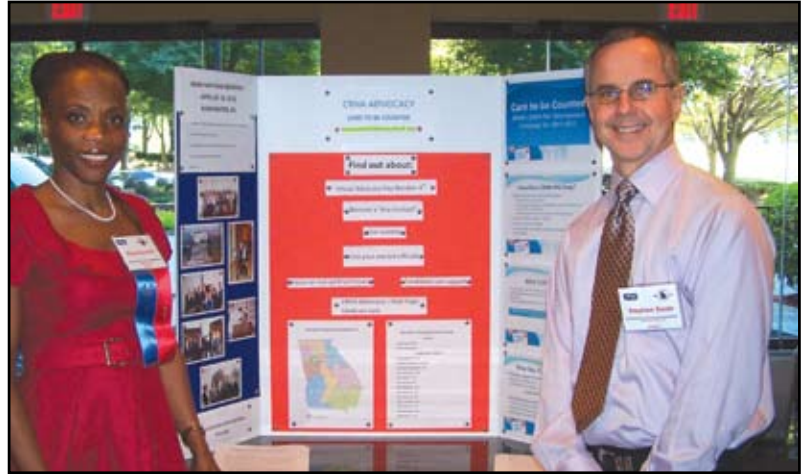

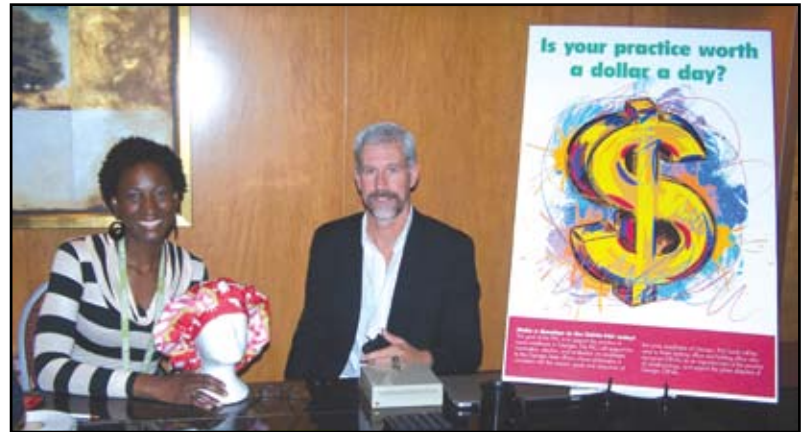

It is essential to establish that relationship in the home district rather than trying to introduce yourself in Atlanta during the legislative session.

Our final goal for the upcoming year is to focus on member involvement in GANA. One strategy to be utilized in this area is that each GANA Committee Chair has been charged with recruiting his or her peers to assist with the work of the committee. My hope is that this action will help recruit more CRNAs into GANA activity. It's important that we keep welcoming new ideas and new people who would like to be involved. There was standing room only in the large capacity Eversole Auditorium located in the Medical Center of Central Georgia for the Class of 2011.

The Keynote Speaker was Tom Kellogg, CRNA, a MCCG staff anesthetist who delivered a powerful and positive address to the students. Also, Brent Dubois, CRNA, GANA President and former MCCG Staff Anesthetist, delivered the GANA MCCG Award to Brooke Kesler, SRNA. Georgia Health Sciences University Nurse Anesthesia School Report

Fall semester is always the busiest time for the Nursing Anesthesia Program. It is the only semester where we have three cohorts of students all at the same time, 20 students are in the didactic phase, and 40 students are in the clinical phase. If that alone isn't enough, this time is also when we go through the 100 or so applications and send out invitations for interviews to be conducted soon after the New Year.

The Program underwent a scheduled accreditation visit from the Council on Accreditation of Nurse Anesthesia Programs (COA) in October. There is a tremendous amount of time and effort involved in preparation for this site visit. Nine months and over 1000 pages of written summaries and documents were compiled to demonstrate how the program meets the rigorous standards set forth by the COA. I am extremely pleased to announce the program did not receive a single citation during the visit. The lead reviewer stated that it was only the third time in his 17 years of doing site visits that he had issued zero citations. The final determination for the length of accreditation will occur this summer, but I anticipate the maximum 10-year accreditation will be awarded. I would like to thank all those who contributed to this successful endeavor.

The Convocation Ceremony for the Class of 2011 was held December 9th, 2011. All 19 students that began the journey 28 months ago have met the requirements for graduation and are eligible to take the National Certification Examination. All 19 students had job offers prior to graduation and most will be staying in Georgia. I look forward to seeing all the wonderful

contributions they make to the profession. Julie Jackson received the Director's Award presented each year in recognition of excellence in clinical practice, contribution to the profession, and commitment to the people of Georgia. Whitney Huffman was the recipient of the GANA Outstanding Student Nurse Anesthetist Award at the GANA 2011 Fall Meeting. The award is given yearly to a Georgia student nurse anesthetist for excellence in academics, superior clinical skills, vigilant service, and professional contributions. GANA Immediate Past President Rose Synsmir also presented Whitney with the GANA scholarship award at the convocation ceremony. We thank Rose for taking time out of her busy schedule to come join us during this occasion.

The Class of 2012 successfully completed their first semester of clinical and the Class of 2013 completed their first semester of didactic. Both are major milestones on their journey to becoming CRNAs.

As always I want to thank all of the clinical instructors. You are the heart and backbone of our program and without you we could not exist. Taking the time to share your knowledge, experience and skills is one of the greatest gifts you can give back to this wonderful profession. GANA Outstanding Student Nurse Anesthetist of the Year Award

Whitney Huffman, who graduated on December 9, 2010, from Georgia Health Sciences University, was this year's winner of the 15th GANA Outstanding Student Nurse Anesthetist of the Year Award. She was presented the award at the 2011 GANA Annual Fall Meeting in Atlanta. The award is based on excellence in academics, exemplary clinical practice, leadership capability in the GANA, potential for future contribution to the practice of nurse anesthesia and professional body of knowledge and contribution to the GANA/GANAS as a student nurse anesthetist. Whitney received \$250.00 and a plaque recognizing her for the award. In addition, a perpetual plaque with her name, alongside all past recipients, will be posted at GHSU until next year's award is announced.

Academically, Whitney successfully met the challenges and rigors of the nurse anesthesia program with a calm and confident attitude, allowing for sound critical thinking. She graduated with a 4.0 grade point average. She consistently received high praise from clinical preceptors during her rotations. Her love for the discipline of nursing is not only evident in her approach to her studies, but is clearly visible in her past professional performance as well as her ambitious goals of earning a doctoral degree preparing her to serve in the research and educational arenas. Whitney was instrumental in protecting the nursing anesthesia program when it was targeted for closure last April due to significant budget cuts inflicted on the Georgia University System. She organized her fellow classmates, contacting state legislators, Board of Regents members, and media outlets, enlightening them on the value of program, and educating anesthesia providers that will provide anesthesia services to the rural constituents of Georgia.

Whitney has decided to stay in Augusta where she has taken a job. ■
