

All Politics Is Local



AANA Elections

Once again GANA is calling on its members to help put Georgia on the national map! Two Georgia CRNAs are on the AANA ballot in 2012. Leslie Ann Jeter is running for AANA Region 2 Director, and Stephen D. Smith is running for AANA Region 2 Nominating Committee. GANA is extremely proud to support Leslie and Steve. Both are currently active in the GANA and have served as its Past President. They have a long history of work and dedication on behalf of the nurse anesthesia profession and they deserve to represent Georgia CRNAs at the national level. Please join GANA and show your support for Leslie and Steve.

As many of you already know, Janice Izlar is currently serving as AANA Presidentelect. She will assume the role of AANA President at the AANA Annual Meeting in August 2012, in San Francisco. Please plan to attend this meeting in order to have a large Georgia contingent on hand to show overwhelming Georgia support and encouragement as Janice takes office.

2012 Legislative Session

The Georgia legislature ended its election year session when the gavel sounded on Georgia's 2012 session which adjourned sine die on March 29th. Some Bills of interest are summarized below:

SB 445 was introduced by Senator Bill Hamrick on behalf of the Secretary of State Brian Kemp. This 800 + page bill attempted to restructure the professional licensing boards. The bill created a new position for a director of professional licensing and established a seven member consumer board that would assume certain responsibilities now in the hands of the professionals appointed to the various boards. The current boards would still exist in an advisory capacity. There was tremendous opposition from numerous health care boards and health care professionals, including nurses. There were even several attempts to carve certain boards out of the bill as autonomous entities. As a result, Secretary Kemp pulled this bill, but indicated that he plans to bring it back in 2013. GANA will monitor.

<u>HB 972</u> was introduced by Rep. Tom Weldon as an effort to combat the spread of pain management clinics, or so-called "pill mills". The bill gave the Georgia Composite Medial Board the authority to license and regulate pain management clinics. The bill allowed only physicians to own a pain clinic. This bill passed both chambers with some amendments, but the final conference version was never brought up for a vote before the session ended.

<u>SB 386</u> was introduced by Senator Johnny Grant on behalf of advanced practice nurses. This bill would have allowed APRNs to order radiographic imaging tests


Wow, Georgia turned out in record breaking numbers this year for the 2012 AANA Mid-Year Assembly in Washington, DC (MYA). Georgia was represented by 40 CRNAs and SRNAs. Nationally there were over 800 members of the nurse anesthesia profession represented. The Georgia members were there advocating for Georgia CRNAs' scope of practice rights. We spent 2 days familiarizing ourselves with current issues and then all day Tuesday, April 17th sending our message to Capitol Hill. We visited all 13 representatives and the 2 senators from Georgia. We were actually able to meet and directly talk to 8 of them.

During the course of the meeting, Leslie Jeter and I were able to participate in the Student Mentoring Program. The primary goal is to mentor and produce future leaders of the AANA. The AANA PAC event was held this year at the Hay Adams Hotel overlooking the White House, Washington Monument and Jefferson Memorial. It was quite a spectacular view. Janice Izlar, Leslie Jeter, Martha Kral and I attended this event. Please take time to "Like us" on Facebook (www.gana.org) and view some of the great pictures taken throughout the meeting. Leslie Jeter and I also participated in the "Meet the Candidates" reception which was held for those AANA members running on the AANA ballot this year. We were both introduced at the Meeting on Monday morning and Leslie gave an outstanding speech in her bid for AANA Region 2 Director. Her speech can be viewed at www.aana.com. When your ballot is delivered to you the second week in May please remember to support your Georgia candidates. Please vote for Leslie Jeter for AANA Region 2 Director and Stephen D. Smith for AANA Region 2 Nominations Committee.

The messages we took to Capitol Hill this year were: CRNAs Provide Access to Safe and Affordable Healthcare, Ensure Patient Access to Pain Care, Support Nurse Anesthesia Workforce Development and Protect Medicare from Threats of Huge SGR Cuts. Our number 1 priority this year was Pain Management. As you know pain management is and always has been within a CRNA's professional scope of practice. We have been reimbursed directly for essential chronic pain management services for well over a decade by Medicare. In 2011 the Medicare agency let stand two Medicare Administrative Contractors (MAC) deny direct reimbursement of CRNA chronic pain services. These two decisions by the Noridian and WPS MACs have had significant impact on care for patients with chronic pain in rural and other medically-underserved areas of the upper Midwest and Rocky Mountain states where CRNAs are the primary providers of chronic pain care.

Our message to Congress is for them to write HHS and Medicare and urge the agency to protect patient access to pain care services and resume direct reimbursement of CRNA services. Please do not be so naïve as to think that just because we are not affected here in Georgia that it won't happen here. You can act now by going to the "Care to be Counted" site on the members only side at www.aana.com. It only takes 3 minutes to get a letter off to your representative and two senators.

In closing, I would like to reemphasize what an honor it has been to attend this year's AANA Mid-Year Assembly, the premier conference for federal issues and advocacy shaping the practice and profession of nurse anesthesia. Again, I would encourage you all to visit the "Care to be Counted" site and review our current issues at stake to our practice. It could very well be your practice that is affected tomorrow. Make plans to attend next year's MYA meeting in April 2013. It will be the single most important intervention you can do for your fellow CRNAs.

Students were active participants in fifteen visits to Capitol Hill where they met with key members of the United States House of Representatives and Senate to discuss pressing issues such as Medicare cuts and reimbursement

policies, pain management services that are routinely administered by CRNAs, and Title 8 funding for the education of future nurse anesthetists. The conference was very enlightening! As a class, we'd like to recognize and thank Steve Smith for his hard work in making this year's Mid-Year Assembly the best yet!

The Class of 2013 (Junior Class) just completed their second semester of school and are looking forward to their break prior to the start of summer classes. During the semester, the students mastered the machine check and finally got into the simulation lab for hands on experience! They practiced smooth intravenous inductions and rapid sequence inductions on "Stan the Man". if they deemed it necessary. The bill passed the Senate, but never made it out of the House Health and Human Services Committee chaired by Sharon Cooper.

<u>HB 675</u> was introduced by Representative Sharon Cooper. This bill amended a state law that inadvertently omitted certain trained nurses from being qualified for licensure in Georgia. This bill expanded the definition of 'approved nursing education programs'. It has been signed in to law by Governor Deal.

SB 367 was introduced by Senator Buddy Carter to grant statutory authority to the Georgia Board of Nursing to promulgate rules requiring continuing competency training as a condition for license renewal. The House and the Senate disagreed on language and a conference committee failed to report a bill.

Scope of Practice

In response to a direct inquiry from a CRNA whether epidural steroid injections fall within the scope of practice of a CRNA, the Georgia Board of Nursing has responded as follows:

'The Board determined that it was within the scope of practice of a certified registered nurse anesthetist to perform epidural steroid injections when performed in accordance with O.C.G.A §43-26-11.1, applicable board rules and Georgia law. Additionally, it is important for a nurse to practice within the scope of his or her knowledge and training and according to the policies and guidelines of his or her facility.

It should be noted that the Board's decision and response to your inquiry should not be viewed as a comment upon or advice regarding any ongoing investigation by other professional licensing boards.'

Mercer University/Medical Center of Central Georgia Nurse Anesthesia Program Update

am very pleased to report that all of our graduates from the class of 2011 passed the National Certification Exam on their first attempt. Also, all of the graduates are busy working as a graduate nurse anesthetist after successfully passing their exam. We are all so excited and proud of every new graduate. This most recent graduating class continues our tradition of greater than an overall 97 per cent first-time board pass rate in our school to date. The first class graduated in 2007 and to date we have had 5 classes graduate.

Also, last week about half of the Class of 2012 and our Associate Director, Rickey King, attended the Mid-Year Assembly in Washington, DC. They had an excellent time and came back to Macon energized and much more knowledgeable about the importance and power of nurse anesthetists' collective and individual voices being heard by Congressional Representatives at the Capital on issues germane to our profession. They also stated that the meeting was extremely informative and there was also some time to enjoy a few well known museums and monuments in Washington, DC, too.

I am also very pleased to announce that a decision about the future of this Program has been made public. The Administration of MCCG, after a contract dispute with Mercer University, has decided to collaborate with the Nurse Anesthesia Program at GHSU in Augusta, GA. The Mercer CRNA Program will close in December 2012 after the teach-out of the current cohort of CRNA students.

However, beginning in 2013, GHSU will utilized MCCG as an instrumental clinical site for their CRNA Students. We will be a major clinical site for about 10 GHSU CRNA students. These students will have no other student anesthesia provider competing for anesthesia cases in this facility. The GHSU students will receive extensive training in the following anesthesia specialties: open heart — on and off pump, major thoracic, major spine-neurological, craniotomies, major interventional vascular, OB Anesthesia, pediatrics, cases performed outside the OR, and major trauma, since this is a Level One Trauma and High Risk OB Facility. The students will also receive training in regional anesthesia and major line placements on actual patients after demonstrating proficiency in our simulation lab.

Additionally, we will retain our office and class room space for GHSU student case discussions, speakers, journal club presentations and peer review cases presented during Quality Improvement case discussions with the entire anesthesia department, too.

I believe with the addition of MCCG's outstanding reputation and clinical facility, the clinical training and experience of the GHSU Nurse Anesthesia Students will help propel this nurse anesthesia program as one of the best schools in the southeast. I look forward to helping Jim Masiongale, GHSU CRNA Program Director, as he prepares for the utilization of the clinical activities available at MCCG next year for his students.

Report from GANA-PAC Chair

Increasing Our PAC Fund

Achieving the scope of practice that CRNAs in Georgia currently have is in large part because of the support of the legislators who have taken an interest in our profession. This is ultimately because they become aware of the value that CRNAs bring to their constituents, which would remain largely misunderstood or completely unknown to them if not for our ability to bring them our message. This information is usually introduced by means of a donation and through other efforts that the PAC fund makes possible. Just as patients need access to care in order to remain healthy, GANA needs access to the legislature to maintain a healthy future for our members. This requires a sustained effort; the effectiveness of which is ultimately determined by the financial support we can generate.

The GANA PAC fund continues to remain at a very modest balance. As discussed in previous editions of this article, the GANA BOD has been reviewing a strategy that some of the other states are employing in order to maintain a more predictable and substantial balance for the PAC. The BOD has recently approved the implementation of the "opt-out model," which will allocate a small percentage of the annual member dues to be designated for use by the PAC. A letter has been drafted that explains how the plan will take place and how it will affect each of our members. The option to participate will be optional, however, it will not increase the amount of dues paid by our members for anyone who consents to this plan. This is just a general overview of what each member will receive in all the details by letter in the near future. or educational uses. New resources will be added as they become available.

Prevent Surgical Fires

As part of its collaboration with the Preventing Surgical Fires Initiative of the Food and Drug Administration (FDA), the AANA has developed a surgical fire resource webpage. Access surgical fire prevention recommendations and resource materials in professional practice on the website.

Pass Drug Shortage Notification Bills, AANA Urges Congress

Directing pharmaceutical manufacturers to publicly notify the FDA of conditions that would lead to drug shortages would help alleviate the problem of drug shortages themselves, the AANA wrote sponsors of legislation on the topic Feb. 16. The Preserving Access to Life-Saving Medications Act of 2011 (S 296/HR 2245) suggests that Congress may be waking up to the need for and benefits of such legislation, motivated by periodic threats of delayed and canceled surgeries and of outages of crucial cancer treatment medications.

Medical Product Shortages

The AANA submitted a letter to the FDA in response to a recently released FDA report titled A Review of FDA's Approach to Medical Product Shortages. The AANA letter detailed recommendations, consistent with the FDA's report, for an action plan to effectively address the drug shortage crisis.

Support LifeBox to Make Surgery Safer Around the Globe

Lifebox is a not-for-profit organization that grew out of a global initiative by the World Health Organization (WHO) to make surgery safer around the globe. Since nurse anesthesia is all about patient safety, the AANA has adopted the cause of this valuable organization and is asking nurse anesthetists in the United States to consider making a donation to support the work of Lifebox. Specifically, the Lifebox mission is "to ensure that no patient dies because a pulse oximeter and basic safety checks were not used during surgery." This project is a straightforward first step: Ensuring that every operating room in the world has a simple, essential device that can save lives – a pulse oximeter. For every \$250 in donations, the program provides a pulse oximeter, rechargeable batteries, universal finger probe, AC/DC adapter charger and cradle, protective case, educational materials and a copy of the WHO Surgical Safety Checklist to eligible clinicians/facilities in low income/low resource areas. A link to Lifebox has been provided on the AANA website. Donations in any amount will be greatly appreciated!

50-State Service Strategy Update

You can go to the website to view a summary of the actions taken in response to the main themes identified from the membership feedback received during the 50-State Service Strategy sessions held at the November 2011 Fall Leadership

Academy. This information includes the development of an electronic catalogue of templates for state association leaders, the appointment of a workgroup to define the current and future roles and responsibilities of the Region Directors, the expansion of AANA boot camps, and the increased use of technology to manage the needs identified by members in the areas of communication, membership and data.

March 1 Medicare Cuts Averted for More Cuts January 1, 2013

Following receipt of more than 5,000 CRNAdvocacy messages from AANA members to Capitol Hill, Congress approved legislation (HR 3630) which averted 26.2 percent in Medicare Part B payment cuts for CRNAs and physicians that would have hit on March 1. The AANA and CRNAs had urged Congress to enact the longest possible relief package; however, the measure only provides relief from possible cuts until January 1, 2013, when cuts in excess of 30 percent will take affect. This will drive Congress to take up additional relief legislation in a year-end "lame duck" session following the Nov. 6 elections.

AANA Response to NY Times Editorial: Reject 17 Percent Cuts to Anesthesia Care

A Medicare Payment Advisory Commission (MedPAC) proposal to cut Medicare anesthesia and specialty care 17 percent over three years should be rejected by Congress and replaced by initiatives to make more efficient use of CRNAs and other advanced practice registered nurses, wrote AANA President Debra Malina, CRNA, DNSc, MBA, in response to a Feb. 22 editorial in the New York Times.

Senate Pain Hearing Reviews IOM Report

The impact of pain in the United States deserves more attention, a Senate Health, Education, Labor and Pensions Committee found during a hearing on Feb. 14. The AANA distributed a written statement at the hearing. Chaired by Sen. Tom Harkin (D-IA), the committee took testimony from the National Institutes of Health, the co-chairs of the 2011 Institute of Medicine (IOM) report panel on "Relieving Pain," and representatives of organizations of patients suffering from chronic pain. According to the IOM, there are 116 million Americans suffering from chronic, intractable pain at an economic and healthcare cost approaching two-thirds of a trillion dollars per year.

HHS Issues More Essential Health Benefits Guidance

On Feb. 17, the U.S. Department of Health and Human Services (HHS) issued additional guidance and "frequently asked questions" (FAQs) regarding "essential health benefits," a critical health reform implementation term governing the development and marketing of health plans in states, and important to CRNAs. Under the agency's intended approach, states would have the flexibility to select an existing health plan to set the "benchmark" for the items and services included in its essential health benefits package. The AANA sent comments to the HHS on this bulletin requesting that the proposed essential health benefits rule should include anesthesia services among the 10 categories of essential services in the Patient Protection and Affordable Care Act (ACA), as anesthesia and analgesia care provided by CRNAs fits into many of the essential health benefits requirements in the ACA.



HHS Delaying Implementation of ICD-10 Compliance

The HHS is delaying implementation of transitions and compliance to a new clinical diagnosis code set called ICD-10 past its original Oct. 1, 2013, "go" date, the agency said in a statement Feb. 17.

AANA Urges AMA Panel to Delay Decision Making on GI Sedation

An American Medical Association (AMA) panel considering changes to the relative value of gastrointestinal procedures is wise to consider alternatives to the current flawed system that allows some double-payment for sedation, but should delay decision making on the issue until the AANA and CRNAs have the opportunity to further review the proposals, AANA President Debra Malina, CRNA, DNSc, MBA wrote to the AMA on Jan. 27. The AANA had been excluded by the AMA's physician-centric process.

Georgia Health Sciences University's Nurse Anesthesia Program Report

Change continues to be the norm for Georgia Health Sciences University. You may or may not be aware that GHSU (formerly MCG) is in the beginning phase of combining with Augusta State University to form a large university that features liberal arts and healthcare education. The new university name has yet to be determined, but we have been told that it will not contain the word 'health' in the name. So those of you that have trouble remembering Georgia Health Sciences University should not despair, that name is going away.

The nursing anesthesia program is in the process of undergoing change as well. You probably received information from GANA on the collaboration between GHSU's nurse anesthesia program and the Medical Center of Central Georgia (MCCG). We along with 2 other anesthesia programs from other states submitted proposals as to how best keep MCCG as a training facility for CRNA students. We are delighted that MCCG chose our proposal. Starting in the fall of 2013 we will accept a total of 30 students. This number is down from the 38 students total that both programs now accept combined. All didactic will be conducted in Augusta during the 1st year as it is currently done and a cohort of 10 students will conduct the majority of their clinical training at MCCG with occasional out rotations to ensure they meet the Council on Accreditation's clinical requirements. The collaboration was also a win for those CRNA's that feel the programs are turning out to many CRNA students. The overall number of graduates per year will be decreased by a total of 8 through this agreement. There will also be a two-year period of time where only 20 students will graduate as the students move forward in the curriculum.

The students have been just as busy. In addition to the rigors of clinical and didactic instruction, all 40 GHSU students, Mercer students, and several Georgia CRNAs participated in the Capital Day events on January 25, 2012, as part of National Nurse Anesthetist Week. This event has continued to grow over the last few years and is a wonderful mechanism for educating legislators on the importance of CRNAs to the state of Georgia. Myself, eight senior students, four students from Mercer, Steve Smith, GANA Federal Political Director and Christy Dunkelberger, GANA Executive Director and Legal Counsel, represented GANA at the annual Rural Health Day at the Capitol on February 16, 2012. And finally, the entire senior class has just returned from Washington, DC after attending the AANA Mid-Year Assembly April 14th to 18th. Greetings! The start of 2012 has been as predicted! We have been very busy during the legislative session. The GANA has been very busy fighting on the front line to protect your practice rights and maintain your scope of practice.

First, Capitol Day was a huge success! We had one of the best turnouts in recent years! There are great pictures of this event on the GANA website. Please make plans to attend next year if possible.

One of the issues the GANA worked on was the legislation proposed by Secretary of State, Brian Kemp to reorganize the professional licensing boards, including the Georgia Board of Nursing. This legislation created a consumer board that would take over many responsibilities of the current licensing boards. The GANA executive director, along with the elected officers and board members met with Secretary Kemp to discuss this legislation and to voice our concerns. Many other professional disciplines also voiced concerns and opposition. Ultimately, Secretary Kemp withdrew SB 445 from consideration for this year.

Mid-Year Assembly in Washington, D.C. was a huge success. More than 800 CRNA's and SRNA's (40 of which are from Georgia)

eslie Jeter CRNA, MS descended upon our nation's Capital to discuss important issues that impact CRNA's and the states that they practice. The GANA along with GHSU and Mercer University students met with Georgia's Senators and Congressmen to discuss Medicare B cuts, Graduate education funding, Pain management legislation, and critical drug shortages. It was a great day and I feel that we got our message out loud and clear. Now we must see what the Supreme Court Rules on the Affordable Care Act.

Nurse Anesthetists in the state of Georgia, please be proactive in protecting your practice rights and ability to earn a living. These issues are more than "politics." Your board members and elected officials work hard on your behalf, but we cannot do it alone. It takes your voice as a constituent to make a difference.
